Report on Ad Hoc Committee progress (presented by Susanne)

 <u>LINK</u> to Survey Review Ad Hoc Committee Report – progress report. Committee to request to Board to approve indirect cost and salary option. A spreadsheet has been prepared for priority species. Proposal will also expand the name of grants to be more inclusive. Discussion of indirect costs.

- <u>LINK</u> to proposal to establish an indirect cost budget line and salary compensation for inclusion in Survey Grant Guidelines. NEEDS VOTE to officially add to guidelines.
- <u>LINK</u> to spreadsheet developed by Paul Marcum showing the priority species recommended by the ESTAC group during the 2019-20 list review. Board members input invited (presented by Paul).
- Paul moved to approve optional 10% indirect costs and up to \$2,000 in salary compensation for the grant guidelines. Floyd seconds. All in favor, none opposed. Motion passes.
- <u>LINK</u> to the current INPS Survey Grant priority species list for comparison (all these species will remain on the new priority list). Species in red are being surveyed. Folks can conduct surveys even without a grant, see Survey Grant Guidelines for more details. Add species to list, send comments and suggestions to Paul. Post this list to our website? That way folks can do searches even if they are not officially awarded a grant. Publish in newsletter. Check with IDNR on publishing list too. Add a category INPS survey grant to POC database?
